As temperatures climb, we are all looking for ways to stay cool.

summer heat

A ceiling fan is an inexpensive way to do so. The fan will not actually lower the temperature, but creates a cooling effect that makes you feel cooler by moving air across your skin. Operate ceiling fans only when rooms are occupied. Turn them off when you leave the room. Ensure fans are running counterclockwise so air is pushed down toward you.



Also, have your air conditioning unit checked to ensure it is working at peak performance. This annual maintenance will help you use less energy and can save money by avoiding more costly repairs. Check Freon levels, and change the air filter regularly to help the unit stay clean. Avoid setting lamps and heat-producing electronics near the thermostat as it will register the heat produced by these items and cause your unit to run longer.

MEMBERSHIP 2021 Annual = **Meeting held June 24**

Singing River Electric held its 2021 Annual Membership Meeting on Thursday, June 24.

During the meeting, General Manager and CEO Brian Hughey reviewed the highlights from 2020 and shared some of the cooperative's plans for 2021. Attendees were introduced to the electric co-op's new fiber affiliate, Singing River Connect, and learned about the three fiber pilot projects in the Brewer, Vestry and Agricola communities. Nearly 2,000 residents of Jackson, George, Greene, Perry and Wayne counties will be eligible to sign up for high-speed fiber in this initial pilot project phase. Singing River Connect is currently taking expressions of interest for fiber service and pre-registering those in the pilot project areas. For more information, visit www.singingriverconnect.com.

Four Singing River Electric members were elected to serve three-year terms on the cooperative's board. One board member was elected to represent District 1, one was elected to represent District 2, and two were elected to represent District 3. There are traditionally three directors up for election each year, one from each district. However every third year, two directors are elected for District 3. This is the district with the most members and is represented by two directors to ensure adequate representation.

Singing River Electric members Milton Driskell, Linda Eckford, Philip Busby, Obie Wells and Richard Fleming served on the 2021 Credentials and Election Committee. This committee reviews and approves board candidates, oversees elections and sees first-hand the efforts made to be transparent when conducting the business of the electric cooperative.

Singing River Electric meeting attendees participated in board elections online, by SmartHub app, by mailed-in proxies or in person at the annual meeting.



2020 highlights discussed at the membership meeting:

- Restored power to 82% of SRE members, 38,000 in the first 48 hours, following category 3 Hurricane Zeta.
- Kept drive through open at all three offices and safely worked through a yearlong, world-wide pandemic.
- Retired more than \$4.2 million in capital credits to SRE members. This was a return of member investments in the coop from the years 1993-1994.
- Retired an additional \$700.622 of other capital credits was returned to members for the year 1990.
- Ventured into fiber service by creating a fiber affiliate, Singing River Connect.
- Worked with SRE members to install 13 new residential solar projects commissioned by Cooperative Energy.
- Gave back in the community by cleaning school yards, volunteering at a food shelter, giving away hard-wood seedlings, supporting STEM and helping **Habitat for Humanity**
- Served electric service to 76,474 meters across seven counties in Mississippi and two in Alabama.
- Donated a total of \$304,708.15 in **Neighbors Helping Neighbors grants** locally since the program began.
- Contributed to local communities and economies by hiring 13 full-time employees in 2020.
- Maintained a total of 7.543 miles of power lines, including 1,511 underground power lines and 6.032 miles of overhead power lines.
- Sold \$1.36 billion in kilowatt sales to power our local communities.
- Returned \$68.800 in Comfort Advantage and heat pump rebates to members.
- Employed 192 full-time employees at three district offices.
- Sponsored four high school youth leaders for the Mississippi Youth Leadership Program. They attended the trip to the state capital but were prevented from attended the trip to Washington, D.C., due to the pandemic.
- Assisted Alabama and Louisiana co-ops following Hurricanes Sally and Laura.
- Answered 103,187 calls from members.

We are excited to get members connected, but building a fiber-to-thehome network takes time. We expect service to become available in our pilot areas as follows, though all dates are subject to change.



- SRE Brewer substation is scheduled to receive fiber service in late September or early October 2021.
- Parts of SRE's Aleco substation in the Vestry community is scheduled to receive fiber service in mid-to-late November 2021.
- Parts of SRE's Agricola substation is scheduled to receive fiber service in late December 2021 or early January 2022.

What is the fastest way to report an outage?

Using the SmartHub mobile app can speed restoration time by directly entering your outage information into our system. Dispatch is then able to assign your power outage for faster repairs. Download the SmartHub app at singingriver.com/smarthub.

Upcoming right-of-way projects

Singing River Electric clears trees, limbs and underbrush from the area around and below the power lines called the right-of-way. Right-of-way clearing helps decrease the number of outages and reduces the risk of someone coming in contact with the power lines.

Here are the substations and surrounding areas that are either currently being cleared or where clearing will begin soon:

- Basin Substation Highway 63, Barton-Agricola Road, River Road and surrounding areas.
- Forts Lake Substation Independence Road, Forts Lake Road and surrounding areas.
- Lucedale South Substation Highway 26, Twin Creek Road, Highway 63 and surrounding areas.
- Escatawpa South Substation Highway 613, Saracennia Road, Coda Road and surrounding areas.
