

SCHEDULE R-23 OUTDOOR LIGHTING SERVICE

AVAILABILITY

Available to any member for automatically controlled private area outdoor lighting at any location where 120 volt service is available from existing facilities, subject to the established rules and regulations of the Cooperative.

INSTALLATION CHARGES

\$35.00 for installation of a standard outdoor light and \$50.00 for installation of each wood pole installed solely for furnishing this lighting service.

For underground outdoor lights, the installation charge will be based on an engineering study. A nonrefundable contribution in aid to construction in the amount of one dollar and fifty cents (\$1.50) per foot for trenching will be required.

The member will be required to furnish conduit for use in the installation of underground outdoor lights where the Cooperative deems necessary. All above mentioned charges are non-refundable.

MONTHLY RATE

The monthly rate shall consist of the following:

1000 x 12 month

POLE RENTAL

For each pole installed solely for furnishing the lighting service the monthly charge is:

WP Wood Pole \$1.70

ENVIRONMENTAL CLAUSE

An environmental compliance charge will be allocated to the member on a per kilowatt hour basis to recover the costs for complying with local, state and federal environmental regulations relating to the generation and transmission of electricity.

POWER COST ADJUSTMENT CLAUSE

The above rate shall be increased or decreased by 0.001 cents per kWh for each 0.001 cent by which the projected cost of purchased power divided by projected kWh sales increases or decreases as compared to the current cost of purchased power divided by kWh sales.

REGULATORY ADJUSTMENT CLAUSE

A regulatory adjustment will be allocated to the member on a per meter or per kWh basis, to cover the expense of all regulatory taxes and fees imposed on the Cooperative by any governmental body, including franchise fees, ad-valorem and property taxes, etc. The regulatory adjustment shall be increased or decreased in an amount equal to the projected annual total of all taxes and fees divided by the projected annual kWh sales to all consumers. Actual tax expense and kWh sales will be used to determine any overage or deficiency in the adjustment applied during the year. Any overage or deficiency will be adjusted on the projections for the succeeding year. The regulatory adjustment will be calculated annually.

SALES TAX

Billing under this rate schedule shall be subject to any applicable State and Municipal sales tax.

CONDITIONS OF SERVICE

- 1. Service under this schedule will be billed monthly with the member's applicable electric service rate schedule. Failure to pay for service under this schedule will be cause for discontinuing electric service furnished member under other schedules.
- 2. Cooperative will not furnish service under this schedule if such service would require the installation of a transformer.
- 3. Cooperative will replace lamps and maintain light fixtures during normal working hours only. Members are responsible for reporting any problems with their outdoor light service.
- 4. Cooperative will only install outdoor lights in areas that are accessible by truck.

5. Members will agree to the following:

- a. To protect the lights from damage as far as they are able to do so.
- b. That failure to provide such protection can result in service under this schedule being discontinued.
- c. To permit tree trimming required for poles, conductors or other apparatus used in furnishing and maintaining service under this schedule.
- d. That the lights, poles and attachment used in furnishing this service will be and will remain the property of the Cooperative.
- e. To receive and pay for service under this schedule for a minimum period of 12 months.

TERMS OF PAYMENT

In the event the current monthly bill is not paid within 14 days from the date of the bill, said bill will become delinquent and service may be discontinued.
